- (1) **NEW MEMBER APPLICANTS** must bring the Application form and appear in person to a club meeting (held the first Wednesday of each month at 7:00 Pm) at the Club house in Bath to have your membership approved by the club. Once approved the member must attend an Orientation session before being issued a membership badge.
- (2) **All New Members are required** to have a **background check**
- (3) **ALL Members** (**Life, Annual Adult, Member & Spouse, Senior, and Youth**) are required to complete and sign a **RENEWAL APPLICATION** each year. In addition you must sign a copy of the **RANGE RULES** and Sign the **Liability Waiver** form required by our Insurance agent before being issued the **GATE CODE**.
- (4) **All Adult (Annual Members only)** are required to work two events or workdays, this entitles you to a reduction of the membership fee. (**Discounted Dues do not apply to Life Members, Senior Members, or youth Members**). When you attend an Event or Workday, be sure to sign the attendance sheet that day to get credit.

RANGE RULES (must be signed annually)

- (1) Lock the gate behind you when using Club Property.
- (2) Membership Cards must be worn at all times when on Club Property.
- (3) No vehicles on the range between March 1st and June 1st.
- (4) A member may bring up to two visitors to the range on any given day. If you would like to bring more than two visitors, you must contact the president for approval prior to going to the range. More than two visitors per member may result in the necessity of a range safety officer being present during the range visit.
- (5) GUN SAFETY-Always keep muzzle pointed in a safe direction.
- (6) When firearms are not in use, all firearms should be kept as follows:
 - a. Action open
 - b. Weapon unloaded
 - c. Cased
- (7) Hearing and eye protection must be worn when range is active.
- (8) NO fully automatic firearms, sliders or similar devices allowed on the range.
- (9) Use designated benches for 50, 100 and 200 yard targets. DO NOT crossfire to other berms.
- (10) Only use pistols at the pistol targets.
- (11) Stay behind the firing line when the range is in use.
- (12) Coordinate target changes with other shooters. Check before going down range.
- (13) No items are to be placed on top of berms.
- (14) Shoot only at designated areas within the target frames.
- (15) PAPER TARGETS ONLY: No exploding targets, no glass or metal targets.
- (16) No alcohol or illegal drugs allowed on the Range
- (17) Vehicles should not be driven beyond the shooting benches.
- (18) Be courteous to other members
 - a. Keep the range clean for everyone
 - b. Pick up your brass and place in marked buckets
 - c. Put targets and trash in the dumpster by the Club House on your way out

ANY VIOLATION OF THE RANGE RULES WILL RESULT IN SUSPENSION OF RANGE PRIVILEGES

I further acknowledge that the use of firearms and other hunting and fishing tools are inherently dangerous activities and that I alone assume the risks of using and employing firearms, bows and arrows, fishing poles or other similar products on the premises of the Ammonoosuc Valley Fish and Game Club located at 1543 Wild Ammonoosuc Road, Bath, NH.

I further acknowledge that the study and application of firearms techniques, hunting techniques and fishing techniques are physically demanding and requires that I be in good physical condition, and free from any disability or physical condition that would prohibit my participation.

I further acknowledge that I have read and understood the foregoing RELEASE OF LIABILITY AND ASSUMPTION OF RISK.
