- (1) NEW MEMBER APPLICANTS** must bring the Application form with a check payable to AVFGC or cash in the amount of \$75.00 and appear in person to a club meeting (held the first Wednesday of each month at 7:00 Pm) at the Club house in Bath to have your membership approved by the club. Once approved the member must attend an Orientation session before being issued a membership card.
- (2)** Renewals are payable by check or cash in the amount of \$75.00
- (3)** ALL Members (are required to complete and sign a RENEWAL APPLICATION each year. In addition you must sign a copy of the RANGE RULES and Sign the Liability Waiver form required by our Insurance agent before being issued the GATE CODE.

I further acknowledge that the use of firearms and other hunting and fishing tools are inherently dangerous activities and that I alone assume the risks of using and employing firearms, bows and arrows, fishing poles or other similar products on the premises of the Ammonoosuc Valley Fish and Game Club located at 1543 Wild Ammonoosuc Road, Bath, NH.

I further acknowledge that the study and application of firearms techniques, hunting techniques and fishing techniques are physically demanding and requires that I be in good physical condition, and free from any disability or physical condition that would prohibit my participation.

I further acknowledge that I have read and understood the foregoing RELEASE OF LIABILITY AND ASSUMPTION OF RISK.

Ammonoosuc Valley Fish & Game Club Range Rules

1. The gate must be left open while the range is occupied. Last person out must lock the gate behind them being sure the lock is under the rubber flap.
2. Membership cards must be carried at all times and present it when asked. Members may bring one guest. Contact the president if more are desired.
3. Vehicles may be driven down range for placing targets, however no vehicles are allowed down range between March 1st and June 1st and absolutely no parking of vehicles on the range.
4. You may shoot from 8am daily until ½ hour before sunset.
5. Safety Safety Safety Always keep your muzzle pointed in a safe direction and when not using the firearm the action is open, unloaded, holstered or cased or in the rack. Hearing and eye protection is mandatory when the range is in use.
6. No full auto firearms.
7. Use designated benches for 15, 25, 50, 100 and 200 yard target boards. Handgun shooters may place a portable target board so the handgun rounds impact the 15-yard berm/target board. The 25 yard berm is for sighting in rifles only. Only handgun calibers are allowed at the 15-yard berm. Shotgun shooters use the portable target board and place so the impact will be towards the 50-yard berm. No hand thrown clays are allowed. Only paper targets are to be used. No items are to be placed on the berms or targets hung in such a manner that the impacts will be into the wood framework supports.
8. All shooters must stay behind the firing line. Don't fire from in front of the benches.
9. Be courteous to other shooters and always coordinate target changes. Clean up after yourself, do not leave your targets on the backboards, police your brass and place into buckets.
10. No alcohol or drugs of any kind allowed.
11. In case of emergency there is a outside telephone on the Club House for calling 911. The reporting address on a sign next to the phone. A first aid kit is in the hallway for the latrines.
12. Please check the website, bulletin boards at Trap Building and Club House for Range Closings and events scheduled.
13. Last person to leave must close and lock the gate ensuring the lock is under the rubber flap.
