Secretaries Summary of Minutes for November were read and accepted

Paul Dolittle read the Treasurer's Report was read for November & December and accepted

They still have 2 or 3 people that want to push it but there is nothing the town can do because there is a New Hampshire law in place. Calls to the town manager and selectboard really helped.

Berms

We did get the pistol berm set up this year. Want to add a little bit more to it.

We left part of the 25 yard berm there. The 50 and the 100 are complete. We would like to add more to the 200 to bring it back up by the road side, if we can get some more material.

Range Rules, Membership Applications

The Membership application for the time being we have it down to 3 pages with separate instructions. Membership application, liability form, range rules make up the membership packet.

Non-Profit Status with the IRS

The club dropped the ball in 2007, they never followed thru with establishing the non-profit. We have basically two choices. We did talk with a tax lawyer, the choices are a 501(c) 7 which is more club based, where it is mainly for the benefit of the members of the club. Yes you can have outside participation, but there are some rules that you have to follow when it comes to the money. Verses the 501(c)3 which may go more in line with the trap shooting education kind of thing. The downside of the 501(c)3 you need to keep more meticulous records of all the money that comes in and goes out. It broadens you up to getting donations from corporations and that kind of thing. Where it is a little toughter as a 501(c)7 private club.

501(c)7 was what was recommended.

Fee for the paperwork with the IRS about \$40

Fee for the tax lawyer - \$90 so far for the consultation
