We would put doors at each end for access. Then we could use propane heaters in there to have a warming area for those shooting. Section in front of the new benches would allow that section to tip up so you could shoot from inside the enclosed space. Mike Emerson has a door he would like to donate. Possibly putting foil faced bubble wrap for the ceiling. Ed Fisher will get quotes for the materials to have them for the February Meeting.
